The FLORIDA Equine Liability Statute is posted around the farm. Please read it in its entirety and sign below to indicate that you have read and understand this statute. This document **MUST** be signed by each and every guest to the farm. These forms will also be available in the barn, so it is our client's responsibility to have guests sign and leave signed forms for management. Failure to do so will result in you being asked to leave the premises.

RELEASE OF LIABILITY

This Release of Liability is entered into on the **date above**. It is by and between EUPHORIA STABLES, (OWNER) and _____ (PARTICIPANT), and if PARTICIPANT is a minor, PARTICIPANT's parent/guardian, _____. It is agreed that to benefit of the use and enjoyment of the OWNERS property, facilities, and services, the PARTICIPANTS, his heirs, assigns, and legal representatives hereby expressly agree to the following:

1. PARTICIPANT agrees to assume ANY AND ALL RISKS INVOLVED IN OR ARISING FROM THE PARTICIPANT'S USE OF OR PRESENCE UPON OWNER'S PROPERTY AND FACILITIES including, but not limited to, the risks of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire or explosion, the unavailability of emergency medical care, or the negligence or deliberate act of another person.
2. PARTICIPANT agrees to hold OWNER and all of its successors, assigns, subsidiaries, affiliates, officers, directors, employees and agents completely harmless and not liable and release them from all liability whatsoever and AGREES NOT TO SUE them on account of or in connection with any claims, causes of action, injuries, damages, cost or expenses arising out of PARTICIPANT'S use of or presence upon OWNER'S property and facilities, including without limitation, those based on death, bodily injury, property damage, including consequential damages, except if the damages are caused by the direct, willful and wanton negligence of the OWNER.

3. PARTICIPANT agrees to waive the protection afforded by any statute or law in any jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release.
4. PARTICIPANT agrees to indemnify and defend OWNER against, and hold it harmless from, any and all claims, causes of action, damages, judgements, costs or expenses, including attorney's fees, which in any way arise from the PARTICIPANT'S use of or presence upon the OWNER'S property and facilities.
5. PARTICIPANT agrees to abide by all of OWNER'S rules and regulations.

INHERENT RISKS

As a participant of equine related activities, I acknowledge that horse-related activities are inherently unpredictable and subject to animal whim. Inherent risks are defined to be those dangers and conditions which are an integral part of equine activities, including but not limited to: (1) the nature of an equine to behave in ways that may result in injury, harm, or death to persons around them, (2) the unpredictability of an equine's reaction to sounds, sudden movements, and unfamiliar objects, persons, or other animals, (3) certain hazards such as surface and subsurface conditions not obvious to the equine participant or not known and reasonably not known by the equine professional or sponsor, (4) collisions with other equines or objects that can be reasonably foreseen as a result of normal equine activities, (5) potential of a participant to act in a negligent manner that may contribute to the injury of the participant or others, such as failure to maintain control over the animal, or not acting within the participants ability.

All equestrian related activities are extremely dangerous, accidents involving horses are frequent, the condition of the land is often hazardous, arena footing is rarely perfect, and injury and physical harm to persons and property is often incurred in equestrian related activities.

As a participant in equine activities, you assume all risk in relation to such activities, regardless of if riding or simply being on the premises of Owner, and hereby take full responsibility for any loss or damage or injury incurred by self, rider, bystander, arising out of or in connection with said event/activity.

Furthermore, the undersigned HEREBY FULLY RELEASE AND FOREVER DISCHARGE Owner, employees, affiliates, and Euphoria Stables from any loss of damage or injury. The undersigned also AGREES TO INDEMNIFY AND HOLD HARMLESS the Owner, employees, affiliates, and Euphoria Stables LLC from any liability, loss, injury or damage, arising out of, or in connection with events, or the riding using or enjoying of a horse.

Furthermore, the undersigned AGREES TO DEFEND AND HOLD HARMLESS Euphoria Stables, its employees and affiliates, and Owner from any and all claims, demands, expenses, cause of action, lawsuits, damages and liabilities of any kind and character or action brought against it by anyone in regard to any loss, damage or injury rising out of any event or in connection with a horse ridden or used by or enjoyed by the undersigned.

Furthermore, I UNDERSTAND AND AGREE THAT EUPHORIA STABLES, ITS EMPLOYEES, AFFILIATES, AND OWNER HAVE NO RESPONSIBILITY FOR ANY LOSS OR DAMAGE TO PERSONS OR PERSONAL PROPERTY REGARDING EVENTS WHILE ON THE PREMISES.

I hereby, intending to be legally bound, for myself, my heirs, and assigns, executors or administrators, waive and release forever all claims for damages against OWNER their volunteers, affiliates, and/or employees and for any and all injuries and/or losses I may sustain while participating in equine activities.
